Dear Sirs

I am writing on behalf of Compton Abbas, Fontmell Magna, Stourpaine and Sutton Waldron Parish Councils and have been asked to confirm that in response to Q29 of the consultation on the Local Plan: ***Do you consider that the land which is identified and safeguarded for the Shaftesbury Outer Bypass and the Charlton Marshall and Spetisbury Bypass should continue to be identified and safeguarded for such purposes?*** All of the Parish Councils confirm that this land should continue to be identified and safeguarded. There are continuing discussions which both the District and County councils are aware regarding a North/South strategic route and if the land currently identified for the purposes of these bypasses is not safeguarded the prospect of ever achieving an appropriate north/south route will be lost. The safeguarding of this land is therefore vital and the Parish Councils can not emphasise strongly enough that the land in question should continue to be identified and safeguarded for the purposes of the Shaftesbury Outer Bypass and the Charlton Marshall and Spetisbury Bypass.
