There should have been more emphasis on non-AONB land. Over 50% of the 'search' areas are within AONB. The scope for greater use of non-AONB land to the south of Blandford Forum has been ignored. In other words, for example, Area E could be expanded, as could the non-AONB part of Area F.

Area F includes a particularly sensitive part of the Dorset AONB, which would be irreparably damaged by residential development, unlike other areas of the AONB around Blandford.

Area K, although in AONB, is notably less sensitive than other identified areas within the AONB, and should not be rejected for development potential.
