- 2) 950 Homes on Shaftsbury Road. Again big impact on load to one of the main routes in and out of town.

Both developments will require changes to infrastructure. How will existing the High School cater for all the new children to the area ?.

Gillingham High street is seriously lacking in the usual shops required for a developing town. It is well served by super-markets, but seriously underserved by other shops , notably clothing shops. Very few high street names have been attracted to the town. The High Street generally looks very down market and not appealing to residents or tourist.

A shortage of decent restaurants and pubs. Limited venues for young people. Far too many charity shops. I think it is the usual problem of very high business rates and properties owned by one of two historic families who restrict the businesses coming into the area.


