Annex A to Consultation. Sustainability.

These policies focus too much on ENVIRONMENTAL sustainability, and not enough on SOCIAL sustainability.

They are too tightly defined, and will neither allow adequate development "in the countryside", nor guarantee acceptable development in towns.

We have concerns about the survival of villages, if they are not allowed to develop. This includes both housing (affordable and market) as well as employment uses.

They make no allowance for mistakes currently being made concerning E Shaftesbury.

In our view, the E Shaftesbury expansion is not sustainable, because, despite a thorough and successful analysis of what was needed;

- the infrastructure required (and funding for it) was not identified accurately enough
- virtually all the responsible bodies failed to appreciate the implications for the services they should provide (education, health, transport......)
- the social housing percentage was allowed to run out of control (and too much was allocated to out-of-area residents)
- the planning conditions were not enforced properly (particularly house density and play areas)
- no progress yet on using employment land (flexibility should extend to use for college(s), budget hotel(s)......)
- the school will now be off-site. (We believe it should still be put on-site in the space freed up by the excessive housing density mentioned above)

Enormous efforts will need to be made to avoid the development becoming a ghetto, isolated from the main town. This is more likely while the trunk route between the Midlands and the Continent passes between them. This cannot be allowed continue till after 2026.

There will never be sufficient infrastructure funding raised by future development in Shaftesbury (it is now too late)

Neither will the S Gillingham development provide funding, because the Plan denies that it is required.

We have no confidence in the Plan's ability to address the problem.

The plan on p216 implies that Wiltshire doesn't exist. Neither is there any apparent co-operation with Wiltshire. A sustainable plan should include co-operation with neighbouring authorities.

Annex B to Consultation. Localism.

These policies give too much power to the Planning Authority, and not enough to Parishes/Towns/Neighbourhoods.

Many errors of interpretation throughout document. Those pertinent to Shaftesbury:

3.45 A Town's NP cannot reduce development below the LP's. Where does that put Shaftesbury's Conservation policies, if the NP wants to tighten them up?

8.100 pre-judges how the town will develop;

2nd bullet point (employment land) should include options of eg college and budget-type hotel

4th bullet point (east of TC land) should give priority to leisure and community facilities, with housing and retail not specifically mentioned

8.118 pre-judges shopping frontages. These should be left to the NP.

8.123 parking: Primarily for NP, only by LP if NP does not address. (Unlikely!)

Annex C to Consultation. Transport Infrastructure.

Rail: No consideration of need for expansion of parking at Gillingham, or for additional station (near Gillingham, or re-open Semley)

Road: Denial of traffic densities in A350 corridor (including C13, which already carries far too much traffic, particularly HGV)

Traffic from Gillingham development will overwhelm this corridor long before 2026

This omission is at odds with turning Christy's Lane into a street. Should there not be thought given to moving the A350 corridor to the W of Shaftesbury, so that it could also serve Gillingham? It could be a more sustainable solution.

The map on p216 should at least show the reserved corridor.
