#### **Duty to Cooperate Statement**

Under the Localism Act and the National Planning Policy Framework ('the Framework') local authorities have to address strategic planning matters in their local plans. The duty to cooperate is the mechanism for ensuring that this happens.

As part of the examination process local authorities should demonstrate how they have **managed strategic planning matters in the local plan in a concise and focused statement.** 

The likelihood is that effective cooperation will be critical in relation to:

- defining the appropriate strategic planning area (SPA)
- agreeing the appropriate plan period
- quantifying development needs within the SPA
- agreeing on the distribution of development within the SPA
- establishing what strategic infrastructure is essential to deliver the required development
- agreeing how and when the essential infrastructure will be provided

The most important aspect of demonstrating the Duty to Co-operate is the outcomes: what was the result of the strategic cooperation and how has this influenced the plan?

#### **Your Duty to Cooperate statement**

#### 1 Introduction

- 1.1 In preparing its Waste Plan, Section 33A of the Planning and Compulsory Purchase Act 2004 (as amended) places a duty on Dorset County Council to 'engage constructively, actively and on an ongoing basis' with other relevant organisations to maximise the effectiveness with which Plan preparation is undertaken.
- 1.2 Under the duty to co-operate, the Waste Planning Authority must co-operate with other relevant planning authorities, as well as other organisations, as set out in Section 4 of the Town and County Planning (Local Planning) (England) Regulations 2012, such as the Environment Agency, Heritage England, Natural England and Highways England.
- 1.3 This statement outlines how the Waste Planning Authority has met the duty to co-operate in the preparation of the Waste Plan. The activities summarised in this document concentrate on engagement beyond the formal requirement of legislation and guidance.
- 1.4 Guidance on the Duty to Cooperate is provided in paragraphs 178 to 181 of the National Planning Policy Framework (NPPF), including a requirement to "demonstrate evidence of having effectively cooperated to plan for issues with cross-boundary impacts" when submitting a Local Plan for examination.

#### 2 Joint Working and Governance Arrangements

- 2.1 The Waste Plan covers the administrative areas of Dorset County Council, Bournemouth Borough Council and Borough of Poole. It has been prepared by Dorset County Council on behalf of the unitary authorities of Bournemouth and Poole under the terms of a service level agreement.
- 2.2 The Waste Plan is overseen by the Bournemouth, Dorset and Poole Minerals & Waste Policy Joint Advisory Committee, which is made up of representatives from the three administrative areas.
- 2.3 The terms of reference for the Joint Advisory Committee are as follows:

'To oversee the production of minerals and waste development documents relating jointly to Bournemouth, Dorset and Poole and to approve these for consultation, and to recommend the submission and adoption of final documents to the three parent authorities.'

2.4 Membership of the Joint Committee comprises:

 Four members of Dorset County Council
 Two members of Bournemouth Borough Council
 Two members of the Borough of Poole
 (Plus substitutes)

2.5 All references in this document to Dorset or the Plan area should be assumed to include Bournemouth and Poole.

#### 3 Purpose of this statement

- 3.1 As a statutory requirement, the Duty to Cooperate will form one of the legal tests to be considered by the Inspector at the Waste Plan's examination, while compliance with the NPPF's requirements for positive preparation and effectiveness form part of the soundness test. This statement provides the evidence to demonstrate that Dorset County Council has met the legal and soundness requirements relating to cooperation in preparing its Waste Plan.
- 3.2 This statement explains the context for the Waste Plan and outlines the stages undertaken in its preparation, before identifying the strategic issues and describing the cooperation undertaken for the following range of organisations;
  - WPAs outside Bournemouth, Dorset and Poole
  - District and borough planning authorities within Dorset; and
  - Other relevant organisations.
- 3.3 By agreement with Bournemouth Borough Council and the Borough of Poole, Dorset County Council undertake work on minerals and waste planning policy documents covering the three authorities. This includes the preparation of the Waste Plan.

#### 4 The Dorset Context

- 4.1 Dorset (comprising the three authority areas of Bournemouth, Dorset and Poole) is located on the south coast of England and has a total area of 265,273 hectares. It is largely a rural county with large expanses of highly valued countryside. The conurbation of Bournemouth and Poole, and the surrounding urban areas, together form the second largest urban area in the south west, with a population of almost 500,000. The population of Dorset as a whole is approximately 700,000.
- 4.2 Dorset is bordered by Devon to the west, Somerset to the north-west, Wiltshire to the north-east and Hampshire to the east. The New Forest National Park is situated to the eastern boundary of the Plan area.
- 4.3 Dorset's environment is distinctive and highly valued. It combines internationally designated heathland and wetland habitats, two Areas of Outstanding Natural Beauty and much of its coastline is a UNESCO World Heritage Site. There are significant historic and cultural assets that contribute to the character and distinctiveness of the area. Consequently, many people in Dorset enjoy a good quality of life, with relatively low crime and the opportunity to enjoy a healthy lifestyle in attractive towns and villages.
- 4.4 The area has a diverse economic base including advanced engineering, marine industries, world renowned companies, and strong-performing manufacturing and service industries. In addition, the rural and coastal areas support food and tourism related businesses.

- 4.5 The area is diverse, from the functional, vibrant hub of the South East conurbation with award winning beaches at both Bournemouth and Poole, to the charming market towns and their attractive rural hinterlands with dispersed villages, the complementary towns of Weymouth and Dorchester (the largest settlements outside South East Dorset), and the natural beauty of the Jurassic and Heritage Coast between Lyme Regis and Swanage. These broad geographical areas define the spatial context of the Waste Plan.
- 4.6 The main focus of development will be in and around Poole and Bournemouth. The Dorset Local Enterprise (LEP) Partnership's Strategic Economic Plan proposes major development at Aviation Park at Bournemouth Airport and regeneration of the Port of Poole. A major urban extension of almost 1,000 dwellings is also proposed at north Christchurch. These proposals together with development around the two Universities in Bournemouth and Poole will help to stimulate the urban economy.
- 4.7 Elsewhere a major urban extension (1800 dwellings) is proposed in Gillingham in the north of the County and over 1200 dwellings in and around Wimborne in the east. In the west, Dorchester will be the focus of development with around 1900 dwellings currently allocated and extensions on the edge of Weymouth will also boost that town's growth by around 1300 dwellings.

#### 5 Priorities for the Waste Plan

- 5.1 The Waste Plan seeks to move waste up the waste hierarchy by making provision for sustainable waste management facilities that optimise waste reduction and reuse in appropriate locations.
- 5.2 The Pre-Submission Draft Waste Plan sets out a spatial strategy that underpins the Waste Plan and establishes the key strategic and local needs for new waste management facilities. The key aspects of the spatial strategy are;
  - 1. Strategic recycling facilities Increased levels of collected co-mingled recyclates in the Plan area means that we do not have sufficient operational fit for purpose facilities in Bournemouth, Dorset and Poole. Over the Plan period there will be a shortfall of between of capacity for managing recyclates. This shortfall will be addressed through the provision of a strategic Materials Recovery Facility situated in South East Dorset on one of two permitted sites. A criteria based policy will enable the development of additional sites if permitted capacity does not come forward or if another site comes forward.
  - 2. Local recycling facilities Several of Dorset's existing household recycling centres, transfer stations and waste management centres are unsuitable and in need of improvement or relocation to bring them up to modern standards and/or to serve growing local communities. The Plan addresses the following requirements through site specific allocations and criteria based policies:
  - Replacement of Blandford Waste Management Centre to manage increased quantities of waste – site allocation
  - Development of a transfer station for the Dorchester area to facilitate the sustainable movement of waste and improvement of the Dorchester Household Recycling Centre to bring it up to modern standards and manage increased quantities of waste site allocations

- Development of a transfer station and replacement of the Wareham waste vehicle depot to facilitate the sustainable movement of waste site allocation
- Replacement of Wimborne Household Recycling Centre to bring it up to modern standards and manage increased quantities of waste, potentially from a wider area including development of a waste transfer station and waste vehicle depot – criteria based policy
- Replacement of Shaftesbury Household Recycling Centre to manage increased quantities of waste, particularly driven by the expansion of Gillingham – site allocation
- 3. **Green waste composting** Increased levels of collected green waste in the Plan area means that we do not have sufficient facilities within Bournemouth, Dorset and Poole. By the end of the Plan period the estimated shortfall in capacity is 37,000tpa. This shortfall will be addressed through the provision of localised green waste composting facilities to facilitate a good spatial distribution within the Plan area, particularly in the west of Dorset. The allocation of land at Piddlehinton will contribute to meeting this need along with a criteria based policy to allow consideration of other capacity.
- 4. **Food waste treatment** It is estimated that there will be a shortfall in energy recovery capacity for food waste rinsing to 57,000tpa by the end of the Plan period. Additional facilities should provide a good spatial distribution of localised facilities within the Plan area. This will be achieved through a criteria based policy.
- 5. Bulky waste approximately 19,000 tpa of bulky waste will need to be diverted from landfill during the Plan period. This will be addressed through the provision of a strategic facility for treating bulky waste, located in south east Dorset, where the largest quantities of waste arise. The allocation of land at Woolsbridge Industrial Estate will address this need. A strategic bulky waste treatment facility should be supported by a network of transfer stations, particularly in the west of Dorset, with the capacity for sorting and/or bulking up this waste for onward transport.
- 6. Residual waste management Landfill capacity in Dorset is diminishing and existing treatment capacity for residual waste is insufficient to meet our projected needs. At the end of the Plan period it is estimated that there will be a shortfall of approximatly 227,000 tpa of capacity for managing non-hazardous waste. Appropriate facilities are needed to manage this waste, whilst ensuring that value is obtained through the recovery of energy wherever possible. Provision will be made for residual waste treatment facility(s) to manage waste derived throughout the Plan area. Strategic residual waste treatment facilities should be supported by a network of transfer stations with the capacity for bulking up this waste for onward transport. The Waste Plan is technology neutral, to allow for the best available technology to be developed. Four site allocations are included to address this need. This includes the intensification of Dorset's only existing treatment facility and the reconfiguration/intensification of three other existing waste management facilities.
- 7. Landfill disposal The Waste Plan acknowledges that there may be a need for landfill capacity of up to 88,000 tpa during the Plan period. This is residual waste that cannot be recycled or treated, including residue from treatment processes. To encourage self sufficiency, the Waste Plan will safeguard future capacity at Trigon landfill site. This approach should ensure that landfill capacity is available locally, should the need arise during the Plan period.
- 8. **Hazardous waste management** Hazardous waste requires specialist management and the provision of hazardous waste management and disposal facilities is therefore considered at

a wider than local scale. Whilst the Plan does not make provision for Bournemouth, Dorset and Poole to become self-sufficient in respect of hazardous waste management, it enables facilities to be brought forward should a need arise to manage hazardous waste arising in the Plan area.

9. Inert waste management - Increased levels of inert waste arising in the Plan area, along with the expiration of temporary planning permissions for recycling and landfill, means that by the end of the Plan period there could be a shortfall in capacity for managing this type of waste. The estimated shortfall is around 272,000 tpa of non-recycling capacity. The shortfall in capacity for the recovery and/or disposal of inert waste will be addressed through the provision of localised inert landfill sites, including sites allocated in the Mineral Sites Plan requiring inert materials for their restoration.

#### 6 Broad Pattern of Waste Movements

- 6.1 The key strategic matter that the new Waste Plan needs consider is how waste from other areas is managed at facilities within Dorset, Bournemouth and Poole and the management of waste arising in Bournemouth, Dorset and Poole at facilities beyond its boundaries.
- 6.2 In 2015, around 1.6 million tonnes of waste is produced in total in Bournemouth, Dorset and Poole. There is currently a network of existing waste management facilities across the Plan area which include both localised facilities and more specialist strategic facilities.
- 6.3 In addition to waste management facilities within the Plan area, there are facilities outside the County that currently manage our waste. Many of Dorset's facilities also manage waste arising from adjoining authorities and further afield.
- 6.4 Some cross-boundary movements of waste are inevitable and reflect the normal working of the economy. Some types of waste also require specialised management methods and for such facilities they often operate at a regional or national level. This accounts for some of the imports and exports experienced.
- 6.5 There are varying levels and types of cross boundary movements between Dorset and its neighbouring waste planning authorities. There is a strong relationship with Hampshire and Somerset in terms of waste movements, whilst there are minimal movements to Devon and Wiltshire.
- 6.6 Environment Agency data tells us how much waste is managed at our facilities and from which area waste originates1.
- 6.7 The total amount of waste received by waste management facilities in Bournemouth, Dorset and Poole was around 2.17 million tonnes in 2015. Of this amount, the majority (over 85%) originated from within the Plan area, demonstrating that Bournemouth, Dorset and Poole are largely self-sufficient in waste management terms. The remaining 15% of waste that was managed in the county was imported from other waste planning authorities. Around 40% of that imported originated from neighbouring waste planning authorities, namely Hampshire

- County Council (including Southampton and Portsmouth), Devon County Council, Somerset County Council and Wiltshire Council (including Swindon). The majority was from Hampshire.
- 6.8 In total 322,000 tonnes of Bournemouth, Dorset and Poole's waste was exported to other counties. This suggests that Dorset is a net importer of waste importing more waste than is exported. Around 59% of the amount exported was managed in neighbouring authority areas, with just under half of all Bournemouth, Dorset and Poole exports being sent to Hampshire. This is partly a result of existing waste management contracts for local authority waste to be managed at landfill sites and treatment facilities in Hampshire, as well as other movements of commercial and specialist waste streams. There is some movement of waste to Somerset, Devon and Wiltshire, and remaining exports are to facilities further afield including a materials recovery facilities in Kent and North Wales.
- 6.9 Radioactive waste arising from the decommissioning of the Winfrith nuclear research and development facility in Dorset is a key strategic issue as the waste will largely be dealt with outside of the county.
- 6.10 Further details on cross boundary movements for the different waste streams is set out in Background Paper 3 'Cross Boundary Movements'. In developing the Waste Plan, the Waste Planning Authority has discussed strategic waste planning matters and cross boundary issues with its neighbouring waste planning authorities and wider authorities as appropriate.

#### 7 Development of the Dorset Waste Plan

- 7.1 The current Bournemouth, Dorset and Poole Waste Local Plan was adopted in June 2006. As of 30 June 2009, all policies except six were saved until replaced by the new Waste Plan.
- 7.2 Preparation of the Waste Plan began in 2012 with a period of evidence gathering and ongoing stakeholder involvement, leading up to the publication of the Waste Plan Issues Paper in December 2013. Drawing on the responses made during this consultation and further work the Draft Waste Plan was published for consultation in July 2015. Following on from this stage an additional consultation on Additional and Emerging Waste Plan Allocations took place during June/July 2016 and three further site options were included in an additional focused consultation in February 2017
- 7.3 Work on the preparation of the new Waste Plan has included ongoing engagement with a wide range of stakeholders throughout these stages.
- 7.4 In addition to these consultation stages, further engagement has occurred through a range of specific work undertaken to support the Waste Plan. This includes the Sustainability Appraisal, Strategic Flood Risk Assessments, Habitats Regulation Assessment and the preparation of the evidence including cross-boundary waste movements, an evaluation of residual waste treatment technologies and landscape impact assessments.
- 7.5 Further detail on the engagement and consultation methods undertaken during the key stages is provided in the Statement of Consultation, with further detail on engagement with individual Duty to Cooperate bodies given in the following chapters of this statement.

#### 8 Engagement with Waste Planning Authorities

- 8.1 Dorset, Bournemouth and Poole are obliged, under the Duty to Cooperate, to engage with other waste planning authorities in the preparation of the Waste Plan. Such engagement has taken several forms.
  - Formal consultation at each consultation stage of the emerging Waste Plan Responses
    made at each stage have been considered and updates and clarification incorporated as
    appropriate. Reports have been published setting out all responses made to each Waste
    Plan consultation and officer response. No specific issues were raised during these stages
    concerning compliance with the Duty to Cooperate.
  - Representations by Dorset County Council to other emerging plans of relevant Waste Planning Authorities.
  - South West Waste Technical Advisory Body The WPA has actively participated in the South
    West Waste Technical Advisory Body (SW TAB) along with other WPAs in the South West
    region. SW TAB provides an opportunity for member authorities to share information,
    discuss cross-boundary and other common issues, review emerging waste plans within the
    South West and enable informal discussion of regional and sub regional waste issues and
    capacity issues.

Over the past couple of years, the South West Waste Technical Advisory Body has been preparing a joint report on the future of residual waste management in its area. The report considers the capacity of landfill sites and treatment facilities in the south west region. It also considers the transition from landfill to energy from waste and the rationalisation of local non-hazardous landfill sites to facilities dealing with waste at a more regional scale. Dorset County Council has played an active part in this work co-ordinating and mapping data on the capacity of treatment facilities. The 'Residual Waste Management in the South West' report July 2017 was reported to the relevant committees of Bournemouth, Dorset and Poole during October and November 2017 alongside the Pre-Submission Draft Waste Plan. Members endorses the report as a useful evidence that supporting the preparation of the Waste Plan and the duty to co-operate.

- Membership of the Minerals and Waste Learning Project Dorset County Council has been
  a full member of the Planning Officers Society Minerals and Waste learning group
  throughout the majority of the preparation of the Waste Plan. In 2017 involvement was
  reduced to 'corresponding' membership. Meetings and the email google group provides an
  opportunity for member authorities to share information on matters of common interest
  and broader items such as reforms of policy and guidance. Discussions related to crossboundary and other strategic waste planning issues also take place.
- Periodic meetings with officers of other WPAs on an individual basis, together with
  contact by email and telephone to discuss cross-boundary issues and review preparation of
  authority's plans. A summary of the meetings with adjoining county WPAs is included in
  Appendix B, Table 1.

- 8.2 In July 2013, Dorset County Council contacted WPAs receiving waste from Bournemouth, Dorset and Poole into their area for management by letter. A summary of the responses received is included in Background Paper 3. Generally, most authorities that responded were not aware of any planning reasons why movements of a similar level to those experienced in 2011 could not continue in the future. However, many noted that it is preferable for waste to be dealt with in line with the proximity principle. Several authorities highlighted planning permission end dates which may affect the movement of waste, however the associated tonnages were small and not therefore considered to be a significant issue to affect the soundness of the Waste Plan.
- 8.3 In January 2017, a similar exercise was undertaken in order to update and review this work. The exercise focussed on strategic waste movements from 2011 and 2015. Where a change in strategic movements was identified, the relevant waste planning authority was contacted. Further details on the exercise and responses received are included in Background Paper 3. No significant issues were identified since where restrictions on movements to specified facilities were identified, these had been built in the Waste Plan's forecasts.
- 8.4 A clear understanding of waste arisings and future projections was an important element in the preparation of the Waste Plan. The Waste Plan Issues Paper, published in 2013, included a series of waste growth projections. Drawing on consultation responses, these were developed and a revised approach was established. Focused engagement with adjoining Waste Planning Authorities on this approach was sought in February 2015. Comments were sought on a series of waste growth scenarios set out for municipal and commercial and industrials waste.
- 8.5 Devon County Council responded to this engagement supporting the general approach to projecting waste arisings.
- 8.6 The Draft Waste Plan was published in July 2015. Responses were received from Devon County Council, Hampshire County Council, Somerset County Council and the New Forest National Park Authority. The response suggested requested some clarification and updating of the information presented but none raised concerns over cross boundary issues.
- 8.7 The WPA has also liaised specifically with authorities expected to manage radioactive waste arising in Dorset namely Oxfordshire County Council, Cumbria County Council and Northamptonshire County Council.
- 8.8 In November 2013, the WPA wrote to the three authorities inviting comment on a draft section on radioactive waste intending to be included in the Waste Plan Issues Paper. A response was received from Oxfordshire County Council and as a result further information was incorporated into the Draft Waste Plan. Cumbria County Council confirmed that the Waste Plans intentions were consistent with its strategy for the management of Low Level waste. Northamptonshire County Council also provided comments on the wording of the draft section on radioactive waste. These comments were addressed in the Draft Plan. Oxfordshire and Northamptonshire were contacted again in January 2017 regarding movements of radioactive waste. No responses were received at this time.
- 8.9 No formal responses were received to the 2016 Draft Waste Plan from other Waste Planning Authorities. This is likely to be because this consultation focused mainly on site allocations and

not on strategic issues. Likewise, only one response was received to the 2017 Consultation Plan. This consultation focused on three site specific options none of which were on or near Dorset's border. A response was received from Hampshire County Council, supporting the Waste Plan's efforts to meet its waste needs.

#### 9 Cooperation with Dorset's District/Borough Planning Authorities

- 9.1 The Dorset County Council Plan area contains six district and borough councils that are responsible for local planning within their area;
  - Weymouth and Portland Borough Council
  - West Dorset District Council
  - North Dorset District Council
  - Purbeck District Council
  - East Dorset District Council
  - Christchurch Borough Council
- 9.2 The local authorities are at varying stages in the preparation of Local Plans. It should be noted that some of the district and borough authorities in Dorset are working together to produce joint Local Plans, whilst others are undertaking plan preparation individually.
- 9.3 While local authorities are not responsible for planning for waste there are, several issues concerning waste that affect the plans being prepared by the WPA and the borough/districts which require cooperation by all authorities;
  - a. consideration of the need for waste management infrastructure, including storage facilities for household and business waste, within development proposals;
  - b. consideration of the scope of new development to generate waste and the need for this waste to be managed sustainably;
  - c. the need to ensure that new non-waste development recognises the presence of existing and new waste management facilities and avoids constraining their operation:
  - d. the need to avoid constraining new non-waste development in the identification of new locations for waste management facilities;
  - e. opportunities for waste management facilities to support other forms of development, including the contribution of energy recovery facilities to the provision of low carbon energy within new housing and commercial developments.
- 9.4 The WPA has engaged closely with its district and borough councils during the preparation of the Waste Plan. The local authorities have been consulted formally at key stages but also through more focused meetings with officers, together with email and telephone contact to discuss relevant issues along the way.
- 9.5 Initial contact with all district/borough councils was made in a letter during February 2013. This letter sought to engage the district and boroughs at an early stage in the preparation of the Waste Plan and raised several specific issues including;

- i. current adopted waste site allocations have they been developed, if not why not?
- ii. suggestions for land that could provide opportunities for waste facilities to address identified needs.
- iii. opportunities for waste management in new housing/commercial developments
- iv. policy guidance for waste vehicle depots
- 9.6 As a result, written responses and a series of meetings to discuss the issues were undertaken during 2013 and 2014, see Appendix B, table 2.
- 9.7 One issue of particular relevance to the district and borough authorities in Dorset is safeguarding. The Waste Plan Issues Paper only made brief mention of this issue. Further work was undertaken and focused engagement with district and borough councils was undertaken in January 2015, prior to publication of the 2015 Draft Waste Plan. A paper explaining the proposed approach to safeguarding waste facilities, waste consultation zones and safeguarding exclusions was sent to the districts and borough councils. A link to Dorset Explorer was also provided showing sites proposed for safeguarding.
- 9.8 No major concerns were received from this focused informal consultation on the approach to safeguarding. Comments received contributed to the development of the 2015 Draft Waste Plan.
- 9.9 Formal responses to the 2015 and 2016 Draft Waste Plans were received from all borough and district councils. Objections to several the site options were made by East Dorset and Christchurch Councils, West Dorset and Weymouth Councils and North Dorset District Council. Further meetings and site visits were undertaken to follow this up, try to address issues of concern and ensure that officers were aware of the context of the Waste Plan and site allocations. In addition, responses were received to the 2017 Waste Plan consultation from Purbeck District Council, North Dorset District Council and Christchurch and East Dorset Councils. Comments referred to site options within the respective authority areas.
- 9.10 In addition, regular email bulletins have been prepared, usually in advance of formal consultations to provide advanced notice to officers in the district/borough councils and councillors.
- 9.11 As well as engaging with district and borough authorities on the development of the new Waste Plan, the WPA has contributed, and will continue to contribute, to the development of Local Plans being prepared by district and borough authorities.
- 9.12 Appendix B, table 2 contains a list of meetings undertaken with district and borough Councils within Dorset during the preparation of the Waste Plan.

#### 10 Engagement with other Duty to Cooperate Bodies

10.1 Appendix A identifies the range of organisations that fall within the scope of the Duty to Cooperate. While these have been included in formal consultations on the emerging Waste Plan, the level of engagement has varied depending on the relevance of the Dorset Waste Plan to the body concerned.

- 10.2 Engagement has been most extensive with the Environment Agency, Natural England, Highways England and the Dorset Local Enterprise Partnership. Engagement has involved emails, meetings and telephone conversations. Appendix B, table 3 contains a list of meetings undertaken with other Duty to Cooperate Bodies.
- 10.3 Detailed site assessments were prepared for all sites being considered for allocation in the Waste Plan. The preparation of these assessments included input from a variety of internal and external organisations. This included Duty to Cooperate bodies such as the Environment Agency, English Heritage and Highways England.
- 10.4 The Marine Management Organisation (MMO) were consulted throughout the preparation of the Waste Plan. A response was received to the Waste Plan Issues Paper in 2014 to confirm that the MMO had no specific comments to make.
- 10.5 The Dorset Local Nature Partnership (LNP) was established in 2012. Dorset County Council has engaged with and consulted the LNP and a number of its members throughout the preparation of the Waste Plan. A representation to the 2016 Draft Waste Plan was received and a result a meeting was arranged with the LNP and Dorset Wildlife Trust to discuss concerns raised.
- 10.6 As the Waste Plan, has developed, the WPA has engaged with the LEP at key stages through formal consultation and specific reports to the LEP Board. Concerns were raised by the LEP to one site in the 2016 Draft Waste Plan. As a result, a meeting was arranged to discuss the issues of concern (see Appendix B, table 3 for further details of meeting). Following this a further report, addressing the issues raised, was presented to the LEP Board at their meeting of the 27 September 2016. In response, the LEP acknowledged that mitigation should satisfactorily address the issues raised.
- 10.7 A further report was presented to the LEP on the 23 November 2017. This report provided the LEP with an update on the progress of the Waste Plan and invited them to review the Plan during the formal consultation period.

#### 11 Engagement outside the Duty to Co-operate

- 11.1 The WPA, recognises that there are other bodies not covered by the DtC who's input is essential to delivering the new Waste Plan. Engagement had taken place with a wide range of stakeholders including infrastructure providers, environmental bodies, developers and waste operators. While these organisations are not covered by the DtC engagement through formal consultation and discussions/meeting on specific issues have been undertaken throughout the preparation of the new Waste Plan, as necessary. Details of these meetings is included in Appendix B, table 4 and 5.
- 11.2 The NPPF highlights the importance of engagement with our communities in plan-making and states that: "Early and meaningful engagement and collaboration with neighbourhoods, local organisations and businesses is essential". While the DtC does not extend to communities, Local Planning Authorities are required to produce a 'Statement of Community Involvement'

- (SCI) that sets out how and when communities and other stakeholders can be involved in the content of new planning policy documents. Dorset County Council adopted a revised SCI in April 2013. In addition, the consultation statement provides further details on consultation with stakeholders throughout the preparation of the Waste Plan. Appendix B includes details of meetings with other key stakeholders.
- 11.3 Waste arisings and projections have been a very important element of the preparation of the Waste Plan. As explained in paragraph 8.5, engagement with a range of bodies has been undertaken to ensure that the correct level of waste growth is being planned for. Focused engagement with the waste industry was sought in February 2015 prior to publication of the 2015 Draft Waste Plan. Comments were sought on a series of waste growth scenarios set out for municipal and commercial and industrials waste.
- 11.4 Responses were received from Viridor and New Earth Solutions. There were no major concerns with regards to the scenarios set out. However, some helpful observations were raised which were considered when updating this work for inclusion in the Draft Waste Plan.

#### 12 Pre-Submission Draft Waste Plan

- 12.1 The guidance and form provided for making representations on the Submission Draft Waste Plan has specifically invited representors to state whether they felt the Duty to Co-operate had been complied with.
- 12.2 Following consultation on the Pre-Submission Draft Waste Plan this report will be updated to provide a summary of the outcomes of consultation, specifically with regards to compliance with the Duty to Co-operate.

#### 13 Conclusion

- 13.1 This report has outlined the ways in which the Waste Planning Authority has sought to engage constructively, actively and on an ongoing basis with relevant bodies on strategic matters of common interest in the preparation of the Waste Plan. This has included on-going discussion and liaison to identify matters of cross-boundary / strategic significance and, thereafter, to find ways of addressing any concerns. This is important because, for the Waste Plan to be effective, it needs to be capable of delivering strategic matters which rely upon co-operation with other bodies. This report demonstrates that such collaboration has been actively sought throughout the plan's preparation.
- 13.2 Notable examples of how this has been pursued include:
  - participation in, and active engagement with members of, the South West Waste Regional Technical Advisory Body
  - engagement with other waste planning authorities with a strategic or cross boundary interest in the Waste Plan in terms of the management of waste.
  - The use of established cross-boundary governance arrangements in the form of the Bournemouth, Dorset and Poole Minerals and Waste Joint Advisory Committee.
  - Involvement of other relevant bodies such as Natural England, the Environment Agency and English Heritage in the development and assessment of the plans options.

#### **Appendix A - Duty to Cooperate Bodies**

Section 33A of the Planning and Compulsory Purchase Act 2004 (as amended) requires cooperation in the preparation of development plan documents by local authorities and county councils, together with other bodies that may be prescribed.
