# The Local Planning Authority (East Dorset District Council) and the Forestry Commission, confirm that they agree the following:

#### 1. New Employment Development

The Christchurch and East Dorset Core Strategy (the Plan) at Policy FWP8 seeks to provide about 30ha of land at Blunt's Farm, adjacent to Ferndown Industrial Estate, Ferndown, for employment purposes.

The Forestry Commission own the land allocated for employment uses and support the intention to release this land for employment purposes within the Plan period. The Forestry Commission and East Dorset District Council have agreed a position with the District Valuer regarding releasing the necessary land to facilitate access to the site from Nimrod Way to the east of the site.

# **East Dorset Core Strategy Review Employment land allocation - Blunts Farm, Ferndown**

Further to our telephone conversation I can confirm that the Forestry Commission is pleased to note, in paragraphs 4.25, 4.29 and 10.47, and policies KS5 and FWP8, that East Dorset District Council proposes to allocate Blunts Farm, Ferndown, for development of B1, B2 and B8 employment uses with ancillary support service such as cafes.
