<b>Evidence of Need</b>	Difficulties routinely experienced and reported to PPGs of healthcare access on the other side of Dorset (or Devon). Evidence continues to grow, despite the best intentions of local health teams, patients are not seeing an improvement in their own outcomes. This particularly relates to mental health, elderly, young people. Online survey conducted over current level of satisfaction with local service provision in September. We also have a significant percentage of postcodes in Lyme Regis falling into the lower quartile for poverty. Regular programme of Health and Wellbeing Activities including Community Lunches, Meet and Remember. Cancer support group now self-sustaining Starting to establish our Care Links Lyme programme which is about Lyme and the surrounding areas starting to look after themselves. Detailed mapping, already under way, of health and care services, whatever their nature, for clinical and public information (part of the 'social prescribing' agenda) systematic explanation in accessible language, for public consumption, of how particular aspects of health and care 'work', and what people are entitled to expect: for example, a summary of	Our main round 4 project of the River Lim path is almost complete which has meant that with the use of local contractors we have brought in just over £200k into the local economy. This has also been designed to ease the transit of people from the local campsites and accommodation into Lyme Regis Town itself.  We are now into Stage 2 of round 5, which if ultimately successful will mean that over £700k is spent on projects in the Lyme Regis and Charmouth area With visitor enhancements to both the seafront and the town forming part of the bid, this will further enhance the appeal of both Lyme Regis and Charmouth as an out of season destination. We also collaborated with our partner Lyme Regis Development Trust to help them secure funding of £24k to enable better wheelchair access to the Hub building which houses youth groups and other organisations.	We have established a large mailing list of members and supporters with whom we can get information to swiftly. We have conducted 2 consultations in Q4 2018 – one to establish revised need so the local plan, and a smaller one to establish the effectiveness of the Gateway card scheme in Lyme Regis.
