## Sustainability Appraisal (SA) Monitoring

5. The Strategic Environmental Assessment (SEA) Directive requires that the significant environmental effects of implementing a plan are monitored to identify unforeseen adverse effects and to be able to undertake remedial action to address those effects. Monitoring of effects is also important where the SA/SEA identifies areas of uncertainty.

### **SA Objectives**

- 6. SA is based on an objectives-led approach whereby the potential impacts of a plan are gauged in relation to a series of objectives for sustainable development. Purbeck, together with the other Dorset authorities, used the Regional Spatial Strategy Sustainability Framework as the basis for identifying objectives that would comprise the SA framework for the Purbeck Local Plan Part 1 and subsequent plans.
- From 2006 2012 we had 15 SA objectives as set out below. From 2012, our Sustainability Appraisals have 8 objectives, although they incorporate all the issues addressed in the original 15 objectives (see table below).

## Monitoring the SA objectives and SA effects

#### SA objectives

- 8. When we first put together the SA monitoring indicators in 2006 to measure the objectives, we included all available and relevant data from Dorset County Council and other sources. Current limitations are as follows:
- Some of the data is no longer available.
- The previous SA monitoring sections did not distinguish what would be used for baseline data for scoping reports and what would be used as part of a monitoring programme.
- 9. Since the adoption of Purbeck Local Plan Part 1 in 2012, we have started work on three further sustainability appraisals, beginning with the relevant scoping report. Each scoping report is an opportunity to look at the baseline data again and see where the main issues are and ensure that all objectives are up to date.

#### SA effects

- 10. We currently undertake a great deal of data monitoring of our Local Plan policies, and we produce annual reports on different themes such as employment, retail, tourism, and so on. All of the monitoring we undertake relates in some way to achieving the SA objectives. For example, the monitoring of an increase in retail provision meets the objectives of promoting services and facilities, widening employment opportunities and helping everyone access basic services.
- 11. Where we identify a problem then we make recommendations in the relevant report. In this way, we have a monitoring programme in place to address areas where we are not meeting our targets, identify unforeseen adverse effects and ensure that remedial action is put in place to address those effects.
- 12. As we produce new Local Plans such as the Swanage Local Plan and the Partial Review of the Purbeck Local Plan Part 1, the development and inclusion of policies which are subject to assessment against the SA objectives provides the opportunity to identify new monitoring indicators that will enable us to check that SA objectives are being achieved, adverse effects are minimised and suitable mitigation is put in place where required.
- 13. For example, the SA on the pre-submission Swanage Local Plan recommends that the current monitoring framework is extended to ensure that the SA objectives of the Swanage Local Plan are implemented and adverse effects are mitigated. Examples include monitoring the provision of SANGs alongside proposed settlement extensions and monitoring the loss of open space in Swanage.
- 14. The table below summarises the SA objectives and how they can be monitored in SA scoping reports and in the monitoring framework.

## **Other Indicators**

15. In a small number of cases, we have indicators that relate directly to SA objectives but are not measured in the Local Plan monitoring reports and may not always be found in all the scoping reports (particularly those prepared for Neighbourhood Plans). The indicators are listed below together with recommendations of what we should do if we identify a problem.

## Monitoring significant negative effects of adopted plans

#### Significant negative effects of Purbeck Local Plan Part 1 (PLP1)

17. No policies in the PLP1 were assessed by the SA as having significant negative effects across any of the SA objectives. This in part reflects the mitigation measures that were incorporated into the plan as part of the ongoing SA process. Further information is provided below.

#### Mitigation measures included in the PLP1

18. The PLP1 set out a number of mitigation measures to ensure that the plan did not have significant negative effects. Implementation of these measures will be monitored annually in this report to ensure that is it provided / undertaken.

#### Monitoring of potential unforeseen adverse effects of adopted plans

19. Each year we monitor our adopted planning policies in the PLP1 to measure our progress and see how well we are doing. Each of the topic based monitoring reports is set out in the table below. The table also includes the policies monitored and a commentary of any policies that are not performing, or are underperforming, and may result in potential unforeseen adverse effects of the adopted plan. Potential adverse effects are identified in accordance with the summary and recommendations made in each monitoring report. The table will be updated annually.

#### Summary and Recommendations

- 20. The SA objectives are monitored as new scoping reports are produced for emerging plans. Any new objectives that are identified, or required amendments to objectives will be set out in the relevant scoping report. Since 2012 there have been no changes to the SA objectives.
- 21. SA effects are monitored annually in a number of ways including through the preparation of topic based local plan monitoring reports, identification of unforeseen effects of adopted local plans, a review of significant effects identified in the SA of

adopted local plans, a review of mitigation measures included in the SA of adopted local plans and a review of other indicators where the data is available.

- 22. The review carried out through this report has not identified any unforeseen effects or areas of concern relating to the delivery of mitigation identified within the SA of adopted local plans.
- 23. A few topic based monitoring reports have identified areas where targets are not currently being met, for example, the delivery of new retail floor space in town centres. However, it is clear that emerging plans (the Swanage Local Plan and neighbourhood plans) will enable related SA objectives to be achieved over the plan period, and it would therefore be premature for this report to identify unforeseen effects at this stage in the SA monitoring process.
