	As set out in the accompanying report, Neal's Yard Remedies considers the Local Plan unsound.		
	Paragraph 8.78 – given that the identified land at Neal's Yard Remedies in Peacemarsh is vacant, it is unreasonable to allocate it for employment uses and thus prevent other more valuable uses being located on site.		
	Due to the oversupply of employment land in Gillingham and North Dorset as a whole, it is unnecessary to restrict the uses of the site to employment. Notwithstanding this, Neal's Yard Remedies will remain on site, and are planning to expand.		
	Policy 17 is considered unsound as it does not allow flexibility to alter housing levels in Gillingham should the Urban Extension not deliver houses as quickly as it was planned, particularly given that at the time of these representations, the Council has not agreed a detailed delivery plan for this major site.		
	Restricting development of a previously developed site for employment uses which are neither viable nor necessary is considered unsound.
