Hall & Woodhouse object to this policy as it is too restrictive and potentially conflicts with the support being given under Policy 27 for the retention of community facilities which may involve additional development to support their retention and future viability, which could include tourist related facilities in addition to the existing community facility.

The policy should therefore at the very least be qualified to cross refer to Policy 27.

This amendment is necessary to remove the ambiguity from the policy and to ensure that the policy and the Plan objectives are effective and justified and consistent with national policy.
