Hall & Woodhouse supports the general objectives of this policy but under Drainage and Flood Protection, considers that the requirement for sustainable drainage solutions to be incorporated into all new development of two dwellings or more is too prescriptive. Whilst the policy includes the wording *appropriate to the development and underlying ground conditions*, it is considered that this should be further qualified, particularly on smaller sites, to include the wording *and where practical*.

The addition of this wording would make this part of the policy more positively prepared and effective.
