**6. Sub-section (f) of policy 32 is unreasonable. There is no justification for stables having to be solely of timber. Very often such buildings will be of block construction faced with timber.

With respect to commercial equestrian use sub-sections (h) and (i) suggest that new buildings for commercial equestrian use will generally be resisted. Whilst it is acknowledged that use should be made (where appropriate) of existing buildings, the suggested wording runs counter to Part 3 of the NPPF (Supporting a Prosperous Rural Economy). This states, specifically, that plans should support the sustainable growth and expansion of all types of business and enterprise in rural areas both through conversion of existing buildings and well designed new buildings.

Furthermore, it advises that plans should promote the development and diversification of agricultural and other land-based rural businesses.
