Public Transport consists of a bus between Blandford and Gillingham (including stopping in Shaftesbury) by the Damory bus company. It runs every two hours from 07.03 to 18.11. This service seems sufficient and needs to be maintained. Building development would mean an increase the number of people residing in the parish which, it is expected, would boost custom for the service.




